
<u>Trustees dissect strategic plan</u>

GALENA — A special meeting was held Thursday to go over the first draft of the Harlem Township Strategic Plan.

The township trustees — Chair Dave Jackson, Vice Chair Adam Holliday and alternate Jon Trainer — went over the 64-page document for two hours, changing words or terms as needed for clarification. Members of the steering committee, township staff, authors Crossroads Community Planning, and the public also provided input in person and via Zoom.

By this time next month, there should be a second, more complete draft available for residents as well as candidates who may be asked about the future of Harlem. As it is, the main thing missing from the current document is a chapter on economic development, to be contributed by Delaware County.

When that next edition becomes available, The Gazette will report on its recommendations. However, an analysis place in front of the current edition outlines Harlem's current condition.

While Harlem was first spurred into action due in part to the nearby Intel One Ohio campus project, it was noted that despite its delay, infrastructure is still being put into place in the area in anticipation of future growth.

Among the proactive steps Harlem has taken since then is proactively establishing overlay districts in order to prevent annexation into neighboring communities. Harlem officials have said they want partnerships with their neighbors, along with non-annexation agreements.

The trustees also discussed the possibility of enhancing Center Village, which is in the middle of Harlem. They also mentioned the opportunity to establish something like the New Albany Foundation and ask any potential developers how their project would support the township's values through such a foundation.
